EPA, MPCA, MDH, OSHA REGULATIONS plus ADDITIONAL COMMENTS AND COSTS

Asbestos Inspections by a MDH Certified Asbestos Inspector are required by OSHA to move or demolish a home in Minnesota. Any mobile home that contains asbestos cannot be removed unless a MDH certified "Asbestos Site Supervisor" is present at all times, and OSHA, MDH, and MPCA requires that all workers on site must be trained asbestos class workers through MDH. Severely burned homes can only be removed by a State Licensed Asbestos Contractor, and must be entirely disposed of as asbestos waste, their cost is considerably higher than the prices listed above. Asbestos inspection lab results will be sent to you as well as copies of the filed MPCA Notification if required by EPA NESHAP regulations (required when mobile home is owned by the park). I will obtain the city permits and schedule any pre-demolition inspection that may be required by MPCA, MDH, the County or the city.

Though I expect the park maintenance to shut off the water going to the home at the riser, I do need access to water to keep asbestos and blown insulation wet. If Styrofoam or blown cellulose insulation is in home, an extra charge will be added to contain the insulation (a normal added cost for 4 to 6 inches of blown or 1-2 inches of Styrofoam insulation is \$.45 per sq ft). Prices above do not include double roofs, double siding or double floors; and do not include removal of debris hidden under home. Prices based on homes empty of personal contents; an extra charge will be added for contents (on MPCA notified homes, contents, including appliances must be removed from home 48 hours before demolition, allowing the MPCA to perform their own predemolition inspection). Any hazardous materials except category I or II non-friable asbestos must be removed from the home before demolition and properly disposed of, which may incur a disposal fee. Major appliances, including TVs and computers, as well as mattresses and upholstered furniture need special handling for disposal and this cost will be added to the home's removal cost. Tree trimming or removal to gain access to the home will incur added cost; normally \$100 for trimming and \$150 for a smaller tree removal. Prices are based on older homes with metal roofs; pitched shingled roofs priced higher (\$.50-\$.70SqFt) due to increased disposal cost. Central AC units must be vacuumed of Freon by a licensed individual, which will add approximately \$120 to the total cost, and the Park must pay for properly disconnecting a hardwired electrical pedestal. I will plug the "normal" undamaged PVC sewer drain-out, but the park must request (after the home is removed) that the gas shut-off lock be installed by the gas company. If park residents use our roll off containers for their own personal garbage disposal, additional fees will occur. We are a "Green" company, therefore we recycle everything possible. This should cover most of what I would run into. Contents in locked garages not included.

ESTIMATED COST PROPOSAL: Remove a 12 ft by 60 ft mobile home with metal roof PROPERTY LOCATION: individual lot addresses forthcoming Northfield, MN.

JOB DESCRIPTION

Perform asbestos inspection of home as required by MNOSHA, OSHA and MPCA asbestos regulations for legal landfill disposal. (Laboratory report from suspect samples taken in asbestos inspection will be attached to final removal contract.) Fill out and submit to the MPCA the required (by EPA NESHAP) 10 day "Notification of Intent to Perform a Demolition"). Obtain all required city licenses and permits. Cover ground next to all sides of home with tarps as required for asbestos or lead removal. If the metal roof of this home is covered with a sealant that contains regulated amounts of Chrysotile Asbestos, proper abatement procedures must be followed, including the following:---If the sealant coating is in poor condition, encapsulate the entire roof in latex encapsulant. Using the Soft Touch Machine, roll the roof upon itself the entire length of the home keeping the asbestos inside the rolled roof. Wrap entire roof in two layers of 6 mil poly as required by the Federal Asbestos NESHAP Laws. With the four types of required hazardous signage attached, transport the asbestos roof to Dem Con Landfill for legal hazardous waste disposal accompanied by as Asbestos Waste Manifest.

Remove remaining home by demolition protecting all utilities to home for reuse in the future. Load, haul and legally dispose of all other debris as "clean demolition" debris.

Notes: Home to be empty of all personal contents. The utility disconnect procedures are covered in the attached "Pricing/Regulatory Guide Sheet". If asbestos flooring or insulation is found, additional abatement costs may be added to what is listed below. The asbestos inspection will be performed by a State Licensed MDH certified "Asbestos Inspector". The asbestos removal will be performed by a State Licenses MDH certified "Asbestos Site Supervisor" as required by State and Federal Law. Soft Touch Demolition is a State Licensed "Asbestos Contractor".
