Northfield Promise received a grant for a playground to be built in the northern portion of Northfield. The City is currently looking to purchase property along the Hwy 3 corridor to create a park and install the KaBOOM playground. PRAB members requested more information on the number of children residing near the proposed parks as well as cost and a plan for maintaining the new park. PRAB asked for the opportunity to review park property purchase information before going to council.

4. 20-038 Riverside Park Canoe/Kayak Takeout

The City will supply the concrete pads and other materials to for the DNR to construct the takeout. Members voiced concern on the size of the turnaround. Some felt it should be larger to accommodate vehicles with trailers. It was also suggested a sign be installed to help those on the river to locate the takeout. Routing of the existing bike path through the takeout was another concern to be taken into consideration before finalizing the project.
