Phase 1 – Study and Determine Solutions for Recommended Improvement,

This project shall study options for improvements to mitigate future flooding of adjacent properties to the Cannon River Downtown.

There are five properties north of the Fourth Street Bridge along the Riverwalk that have flooded from recent events or had to deploy flood safety measures such as sandbags to prevent their properties from flooding. In addition, there are three properties south of the Fifth Street Bridge that the City doesn't believe they have flooded but they have had to sandbag their properties to prevent flooding.

There are three City park properties, Ames Park, Riverside Park, and Babcock Park that are prone to flooding,

Task A: Data Gathering

- Hold a project kick-off meeting to determine specific project details. This meeting will include discussing various project logistics such as the schedule for the study and provide more background on the project such as Northfield Vision for Downtown.
- Complete field survey of properties impacted by flooding
 - o Downtown Riverwalk, and adjacent building low openings, and low floor elevations.
 - o Ames Park along river
 - o Riverside Park along river
 - o Babcock park along river
- Gather As-builts and GIS Data from the City
- Review drainage and hydraulics for properties on the east and west side of the Riverwalk and identified in the attached exhibit.

Task B: Evaluate Flood Mitigation Solutions

- Review flood solutions such as extending and rebuilding existing Riverwalk walls, new flood walls, temporary walls, property acquisition, and other solutions.
- Prepare preliminary cost analysis; provide estimated opinion of construction cost along with indirect costs.
- Develop operation and maintenance cost for proposed recommended solutions.
- Provide flood improvement options that will minimize the flooding of City park properties.
- Map 50-year, 100-year, and 500-year return periods pre-mitigation and post-mitigation
