## AFFIDAVIT OF MARIANNE ELLIS

MARIANNE ELLIS, being duly sworn under oath, states the following:

- 1. I am an investigator at the Office of the Minnesota Attorney General.
- 2. On the afternoon of Friday, January 1, 2021, I visited the Alibi Drinkery bar and restaurant located at 20851 Holyoke Ave., Lakeville, Minnesota. I looked inside the restaurant and saw at least seven people seated at tables eating and drinking inside the restaurant at the tables by the windows. Behind those tables, I could see more tables but was unable to determine how many people were seated at those tables.
- 3. All of the tables that I saw occupied had at least two people seated at them and multiple tables had more than two people sitting at them. Some of the tables with people sitting at them were closer than six feet from other tables that also had people seated at them. It was clear that the people seated at the tables were eating and drinking inside the restaurant, not waiting for take-out orders. The people I observed sitting at the tables were not masked or social distancing. Attached as Exhibit A are true and correct photos I took of the Alibi Drinkery during my January 1, 2021 visit.
- 4. On the afternoon of Sunday, January 3, 2021, I again visited the Alibi Drinkery bar and restaurant. I looked inside the restaurant and saw at least 15 people seated at tables eating and drinking inside the restaurant at tables throughout the restaurant. The Minnesota Vikings game was showing on and it was clear patrons inside were eating and drinking and not waiting for take-out orders. Many were watching the football game. All of the tables that I saw occupied had at least two people seated at them and multiple tables had more than two people sitting at

them. Some of the tables with people sitting at them were closer than six feet from other tables

that also had people seated at them.

5. On the afternoon of January 4, 2021, I again visited the Alibi Drinkery bar and

restaurant. I looked inside the restaurant and saw at least seven people seated at tables eating and

drinking inside the restaurant at tables throughout the restaurant. Some of the tables with people

sitting at them were closer than six feet from other tables that also had people seated at them. It

was clear that the people seated at the tables were eating and drinking inside the restaurant, not

waiting for take-out orders. The people I observed sitting at the tables were not masked or social

distancing.


