V. REPORTS

a) Director's report (Draper)

Circulation and use statistics have been improving over the past month. Stop motion animation program with Summer Blast middle-school students was successful and fun. The 'History of the Archer House' program will be re-broadcast on NPB. Natalie continues with first Friday radio spots. There was a public challenge at county level to the library funding.

Discussion of school mask mandates. The Site Improvement Plan has Math, Social and Literacy goals with the literacy goal of 80% of students proficient at grade level. The library could help with the goal by having more early, pre level 1 and decodable, readers available.

iv.Arts and Culture Commission (Draper)

The Riverwalk step painting is complete as well as the Adam Turman roundabout murals.

v. Northfield Promise (Charlton, Turek)

Helping to reinforce the school district message and reach literacy goal. Funding had been cut, but has been restored. There was one Reading Core position at Bridgewater left vacant, Mayor Pownell filling the other position. New this year teachers are using the 'Talking Points' app which also allows for simultaneous translation between teachers and families.

VIII. NEW BUSINESS:

a) Strategic plan process update

The community survey has been created and is in the process of being publicized. Using the radio, newspaper, HHC, Shelf Life newsletter and flyers to get the survey out. Stake holder workshops in the end of Sept./Oct., first with staff then smaller groups. Northfield Promise has an Oct. 25th literacy meeting that would be perfect for a shortened conversation. Also utilizing the library board and FFNPL board in possibly early Nov. and teacher groups in early Dec.. Day Care providers would also be an informative survey group.

b) Discuss Fine Free in 2022

Many SELCO and other libraries have become fine free as a way of eliminating barriers to access. Fine free does not mean fee free with lost materials still being charged. The change has been made in the budget for next year. Discussion was held on how to implement to make sure materials are still returned in a timely fashion due to the lack of fines.

c) Approve revision to circulation policy

Motion to approve the fine free revision to the library circulation policy made by Board Member Zsolnay; seconded by Board Member Turek. The motion passed with the following vote:
