### **OPEN PUBLIC COMMENTS**

Todd Bornhauser, President Northfield Area Chamber of Commerce, commented on possibly changing the date of the Council meeting so as not to conflict with Night to Unite. Spoke regarding the temporary health care dwelling item, the State legislation and noted he hopes it will come back to Planning Commission as well as having a discussion with developers on how this might work for Northfield. Spoke regarding the Chapter 50 changes. Stated he appreciates the compromise discussed at the last meeting. Asked Council to consider hospitality industry when discussing the ordinance. Noted that it is incumbent on owners to police themselves to be good neighbors.

Don McGee, 710 Highland Ave., spoke regarding disappointment on not receiving revenue and expense reports and was hoping to get them every month. Asked Council about information that came out May 31 regarding expenses being under budget. Asked about fund balance report.

## <u>Res. 2016-084</u> Consideration to increase funding for the Arbor Street Crosswalk Improvements.

Public Works Director/City Engineer Bennett introduced this item and answered questions posed by Council. City Administrator Martig answered questions posed by Council.

A motion was made by Council Member Zweifel, seconded by Council Member Nakasian, to approve Resolution 2016-084 - Accept Quotes and Award Contract for Trunk Highway 246 and Arbor Street Crosswalk Improvements option 3 including: authorizing staff to enter into a contract; authorizing the installation of the bumpout and the Rectangular Rapid Flashing Beacon; and authorizing the additional \$37,600 fund transfer. The motion carried by the following vote:

#### **10.** <u>Res. 2016-080</u> Consideration of an Agreement for Storm Sewer Improvement

Mayor Graham noted that items 10-13 are all related to the Woodley Apartment project and that there would be one introduction and one public comment period for all four items. Community Planning & Development Director Heineman introduced these items. Public Works Director/City Engineer Bennett provided information on the actions requested related to the project, information related to drainage on the property, and answered questions posed by Council.

Jonathan Davis and Lauren Davis, thanked everyone that talked with them about their concerns. Noted their primary concern is the process is moving quickly and neighborhood is not adequately prepared. Stated the final approval feels rushed. Seeking reassurances that the improvements being made are at no cost to surrounding neighbors, noted outside engineering opinion, asked about plan for a fence for safety and privacy, and requested the area be surveyed and dilenated clearly.

Marlene Vanasek, spoke regarding a drainage pipe and area with standing water. Stated it would ideally be drained out with this project. Asked about pipe being large enough to take care of the water.

Rick Vanasek, spoke about drainage and a large hole. Noted two areas where water ponds. Spoke regarding standing water in basement in neighboring homes. Stated that were told 35 years ago that this was an outlot and would never be built. Spoke regarding multifamily being built next to single family homes and parking and lighting issues.

*C.* Heineman answered questions posed by Council. Noted fencing is not required as part of the development plan or land development code. Noted screening and landscaping has been included and concentrated in the area in question.

At 8:05 pm C. Ludescher called for a point of order on germaneness. Mayor Graham agreed and asked C. Nakasian to stick to the subject.

At 8:12 pm C. Ludescher called for a point of order related to germaneness. Mayor Graham asked Council to stick to the storm sewer issue.

Police Chief Nelson introduced this item and answered questions posed by Council.

Caitlin Elliott, representing Haider Alnomoni H & S Inc., spoke regarding Sec. 3-27 regarding the fine and penalty. Noted Mr. Alnomoni's previous violations, including an illegal item in his store. Stated that Mr. Alnomoni had passed numerous checks and that he takes the violations seriously. Mr. Alnomoni has fixed the problem with the store video. Ms. Elliot asked the City Council to exercise discretion in this matter and asked that if suspension is imposed, it be non consecutive days over 3 weeks specifically 8/14 & 8/15, 8/21 & 8/22, and 8/28, 8/29 & 8/30.

Dianne Burry, 709 Summit Ave. shareholder at Contented Cow, spoke regarding proposed changes, review of noise complaints and asked if the proposed changes address the source of the complaints. Asked Council to approve option 2 which includes until 11 pm Thursday and Midnight Friday and Saturday.

Don McGee, 710 Highland Ave., spoke in favor of option 2. Stated that the discussion two weeks ago was troubling. Noted that Council shouldn't rewrite an ordinance from the dias. Asked that Council rules of business include that the Council never amend an ordinance from the dias and that any changes be brought in writing.

Laurie Hoheisel, Owner of Froggy Bottoms, noted this is a safety issue not a fishing issue. Spoke regarding problems with lures on the patio and hitting patrons. Asked Council to approve the ordinance.

At 10:03 pm C. Peterson White appealed the ruling of the chair and noted that she didn't have an opportunity to comment on the issue.
