OPEN PUBLIC COMMENTS

Suzie Nakasian, 713 4th Str. E., speaking as a citizen and resident, expressed apology and regret regarding being pushed by events at the last meeting that resulted in her calling the Mayor a bully. Noted conversations and process require close following of the rules and the Council needs to be very transparent and clear. Commended Council for the fierce protection of the principles and rules. Noted that she is grateful for the opportunity to have the kinds of conversations Mr. Ludescher made possible at the beginning of the meeting.

Julie Kopp, 1200 Superior Dr., spoke in favor of keeping entire Fargaze Meadows as one piece. Asked what resolution authorized the removal of 4.6 acres. Concerned with making Abbey Road a through street. Spoke regarding previous plans for the area and many homes proposed.

Karen Moldenhouer, 704 Ford Str., spoke regarding major flooding near Ford Street and the installation of the swale. Noted the swale has helped, but is the only thing that has been done. Asked Council to step back and fix the issues. Stated that additional houses and street extension would add to impervious surface and flooding issues. Asked Council to view the area. Noted that Abbey Road goes nowhere.

Police Chief Nelson introduced this item and answered questions posed by Council.

Laurie Hoheisel, 407 3rd Str. W. & owner of Froggy Bottoms, reiterated that this is an issue of safety, not a fishing issue. Noted issue of dangling lures on private patio from people trying to cast around the building. Asked the Council to consider the safety of the proposal.

A motion was made by Council Member Zweifel, seconded by Council Member Pownell to have the Second Reding of Ordinance No. 983 - Amending City Code Chapter 50-Offenses and Miscellaneous Provisions - Restricting Fishing on the West Riverwalk Area.

REPORTS FROM THE MAYOR AND COUNCILMEMBERS

C. Pownell - None

C. Zweifel - Attended the Park Board meeting. The Board had a tour of City Parks related to pollinator protected areas. The Board made a recommendation to start with a triangle of Odd Fellows Park on the St. Olaf side near Forest Avenue. Attended the Bridgewater Township meeting on Wild Parsnip and noxious weeds and forwarded the information to staff. Bridgewater Township will be putting together a map of areas of concern and spearheading effort for control.

C. DeLong - Reported on the Planning Commission meeting. They discussed temporary healthcare dwellings and tiny houses, and are reviewing outstanding LDC items that need to be addressed in the work plan. Noted that the Highway #3/3rd Street intersection is open and appears to be working well, with the exception of some illegal left turns.

C. Peterson White - Spoke regarding newly painted crosswalks and moving of the bollards at 5th and Washington Street. The improvements seem to be working with fewer confused pedestrians and slower moving traffic. Reported on the CVB Board Retreat led by Lisa Peterson. Noted brainstorming on marketing, branding, and funding. Working with staff to improve the clarity and flow through of lodging tax payments. Noted new B&B, Contented Cottage, opening at the end of this month.

C. Nakasian - Spoke regarding tree policy and organic pest policy. Encouraged review of policies, including the noxious weeds policy. Commended Middle School for opening of cross walks and noted that staff has been helpful with communications. Attended Minnesota High Speed Rail Association meeting in Red Wing.

C. Ludescher - Thanked everyone for their patience with the meeting.

ADMINISTRATORS UPDATE

City Administrator Martig reported on the following:

- *Staff is continuing to work on the budget. This will be the main focus of the upcoming work session. Public Works will be a key item for discussion.*
- *Gearing up for Defeat of Jesse James Days. Coordinating potential scheduling changes that may happen due to wet grounds. Will communicate any changes.*
- *Will be following up on people illegally taking left turns and looking at signage at the Third Street/Highway 3 crossing.*
- *Noted NAFRS will have a special meeting at the end of the month to talk about a taxing district. They are also working on facility planning. A resolution was acted on at a prior meeting related to the existing location and flood control. Staff has weighed in that they are comfortable at this stage. Looking at funding and ownership recommendations with financial consultants, bond counsel and city attorney.*
- *Reviewed the revisions made at the 5th/Washington Street intersection.*
