Heineman introduced Whillock to review the NEC quarterly report. Whillock reviewed his PowerPoint covering the history of the NEC, its mission statement, benefits the NEC provides to the community, scope of services, and testimonials.

Heineman asked the EDA members to discuss the terms of the NEC contract to help move forward with the 2017 budget. Martig stated with the new staff person coming he would recommend a one year commitment with \$45,000 as a contribution.

Gehring supports a reduction of funds to the NEC next year because of the new staff person and a stronger Chamber. Jackson would support current funding for a year and then review if the full funding is needed after having the new EDA staff person. Ackerman supports a one year contract, would like to see the NEC fully funded, then have a work session to coordinate ideas, roles and make adjustments for 2018. Bornhauser stated he would like to ask for the full levy amount and then decide how much to spend in certain areas based on the operating budget and the role of the EDA staff person.

The EDA members concluded they would like to have a work session (with the entire board) to discuss how the NEC and EDA staff person will impact allocating funds for the 2017 EDA budget.
