Presentation of Community Solar Subscription Opportunity.

City Administrator Martig introduced this item. Jane Qually & Rick Masloski, Community Solar, presented information on the Community Solar Garden Proposal and answered questions posed by Council.

Matt Rohn, 908 First Str. W., urged Council to support community solar. Noted opportunities for participation are closing fast. Reported on the 2013 Greater Community Climate Change Summit. Noted Northfield Community Solar will gain financially from subscriptions sold. Noted his research of Minnesota Community Solar and Cypress Creek.

George Kinney, 1814 Van Buren Court, Chair of EQC, and formerly involved in energy task force. Stated both groups are working on issues of renewable energy. Encouraged Council to continue work on this and referenced the related strategic initiative.

Brian Nowak, 515 Nevada Court, asked Council to consider other factors as they consider Community Solar. Stated he came to Northfield because it is a progressive community. If this project meets fiduciary tests, it should be a no brainer for the City. This will attract progressive people who want to invest in the community. Asked Council

to consider the urgency or renewable energy sources and climate change.

Mary Jo Cristofaro, stated we are democratizing energy by sharing who gets to produce it. Creating own local energy makes a community more resilient. Thanked Council for considering this initiative.

Victor Summa, 812 St. Olaf Ave., thanked presenters, commenters and representatives of the EQC for attending. Spoke in favor of the initiative.
