If the City pursued this, we wouldn't have to wait for State funding. Noted a pedestrian underpass could solve the pedestrian issues at Jefferson Parkway/246.

C. Colby - Thanked City Clerk Little for the minutes and City Administrator Martig for answering his questions prior to the meeting. Attended Finance Subcommittee meeting, Mill Towns Trail meeting, and Neighbors United meeting.

Mayor Pownell - Noted letter received from St. Dominics and signatures regarding Municipal ID. Noted Mayor's Youth Council (MYC) meetings are Wednesdays at 7 am in Room D107. Will distribute meeting calendar when available. Noted she is trying to further the relationship between the MYC and the entire Council and would like to get one other Council Member to attend meetings with her. Recognized the MYC members in attendance at the meeting.
