OPEN PUBLIC COMMENTS

Victor Summa, 812 St. Olaf Ave., spoke regarding confusion and asked if comments will be allowed on item 18A. Asked about intentions for comments on item #9. Mayor Pownell noted comments will be made during public hearing for all budget items.

Dan Christophersen, co-owner of Napa, 108 7th Str. E. and 1908 Michigan Dr. Distributed pictures of parking on 7th Street and customer parking surrounding NAPA. Noted letter he sent late in the day to Councilmembers. Spoke regarding options for the project and urged Council to approve Option 4 to maximize parking spaces. If not option 4, asked Council to approve option 3. Stated concern with less than a 30' street width between bumpouts. Noted he is not fan of the raised intersection and feels the same effect can be acheived with 4- way stops at those intersections related to traffic calming.

Will Schroeer, 206 Winona Str. Spoke regarding talks with business owners interested in sharing parking spaces in private lots. Asked Council to give staff and owners time to work out possibilities. Noted the Carleton Math Department runs a free statistical consulting program and are offering to us a downtown parking study free of charge during winter term. Wlling to work with whoever is interested. Part of the NDDC parking and street subcommittee and they plan on taking them up on offer. Noted walked 6th & 7th Street intersections today and they are full of ice. Noted the raised intersections are ice free.

Don McGee, 710 Highland Ave.. Spoke regarding parking downtown. Stated he repeatedly hears from businesses about the need for more parking. Asked about future needs. Stated will never have the opportunity to add parking spaces again if not put in now. Spoke regarding raised intersection. Asked if the ramped up intersection is used, is it going to appear as a raised intersection. Asked if the sidewalk will need to be raised and if there will be curbs and curb extensions.

Mike Witt, Witt Brothers 701 Division and 507 Fremont Str. Spoke regarding increased occupancy at the Phoenix building, NAPA, and other new and proposed businesses in the area. Asked Council to vote for the proposal with the maximum number of parking spaces. Stated he can live with the raised intersection and will work with staff to insure there aren't any flooding issues on his property related to the intersection. Noted lack of parking will choke the businesses. Stated this area is seeing a lot of increased business and traffic.

Bruce Stowe, Commander of VFW, 516/518 Division Str. Expressed concern for any loss of parking downtown. Noted increased patronage in the area and the upcoming opening of Armory Square. Noted they rely on patrons to bring in business to the VFW. Patrons need a place to park. Noted VFW funds are distributed back into the community.

Marcea Fraser, 702 Washington Str. Discussed the design around her driveway. Stated she would like to get the driveway back and be able to park in it rather than getting a permit every winter and having to park vehicle on the yard.

Chris Kennelly, Bluewater Properties 205 Water Str. Spoke in favor of new options 3 & 4. Wants to make sure the City does not to lose sight of parking in all of downtown. Requested the City look at extending zoning to south end of Division Street.

David Ludescher, Northfield. Stated he hasn't heard anything on the Waterford matter and asked about the City paying Waterford Township. Stated the City Council hasn't responded formally to the Charter Commission regarding giving money to Big Ten and there was no resolution authorizing a legal opinion on the Charter and stated he feels the opinion was wrong. Stated losing parking will have a negative effect on businesses in the downtown and businesses are needed to keep the downtown viable. Asked Council to not go with increased levy. Noted property taxes are scheduled to go up 40%.

Todd Bornhauser, Northfield Area Chamber of Commerce President, thanked Council for listening to business community and adding another alternative for the street project. Stated parking and safety are important. Asked Council to address a stop sign on 7th & Water. Stated he thinks there is an option to add a few more parking stalls at the west end of 7th Street and that 6th/Division and 7th/Division need to become 4- way stops. Noted there is a lot of redevelopment that can happen in the south end of downtown.

Mayor Pownell declared the public hearing open at 7:22 pm. Mayor Pownell noted comments will be taken during the public hearings for items 9-15 and 16-17.

City Administrator Martig introduced this item and answered questions posed by Council. Finance Director Angelstad provided information on this item and answered questions posed by Council.

Bruce Stowe, VFW Commander, 516/518 Division Str. Thanked staff for the presentation. Noted a 23-27% increase for their property. Noted they cannot afford to lose parking while getting a significant increase in taxes. Noted the need for more business to address taxes and that businesses need more tax breaks.

Paul Fonstad, 2008 Sibley View Lane. Spoke regarding taxes and that all entities are raising rates. Estimated his market value increased 7% and homestead exclusion went down by 20%. Spoke regarding fees. Stated Rice County hires a 3rd party to do evaluations. Stated he is retired and asked to explain how to pay the tax bill with 2% increase in medicare.

Don McGee, 710 Highland Ave. Thanked staff for the great background information. Noted increased valuation, not increased tax base. Noted 14% increase in his taxes and asked how all taxes can be going up. Asked if the City is taking in all that money. Asked Council to leave levy as is.

Doug Oines, 1900 Sibley View Lane. Reviewed tax records from 2010 - present and noted a 37% increase over 10 years. Noted value of home decreased 3% during the same time period.

Dale Hanson, 2016 Lake Dr. Asked about Rice County reevaluating properties. Noted \$400 increase from one year to the next with the levy on top of it. Stated he is on a fixed income and cannot afford the increases to live in Northfield or anywhere else.

Victor Summa, 812 St. Olaf Ave. Spoke regarding previous comments being on point. Stated the PowerPoint and information provided were overwhelming. Noted information given very good, but very complex. Noted information should have been available in April and explained in May. Asked about statement that Rice County is regulated by what they can do and stated they may not be abiding by the law. Noted anything staff and council can do before December would be helpful.

Todd Bornhauser, Northfield Area Chamber of Commerce President, stated the need to concentrate on the budget increase. Stated the private sector struggle is they can do a wage survey, but can only pay what they can afford. Stated the wage study

implementation could have been done differently.

Noted he can now apply for a drivers license and pickup medication at a pharmacy without being questioned. Noted the expenses in legal fees and other issues. Noted he is an immigration lawyer and spoke regarding foreign passports, OFAC sanctions, and provisions related to residency and allowing parents to use presence on school records as proof of residency. Questioned the limitations of a US marriage certificate.

Alberto Mijares. Noted he has lived in the community for 20 years with friends and family here. Stated ID would be helpful for use at the pharmacy or stores when needing ID, for opening a bank account and cashing a check. Noted many people don't want to carry their green card and this will be a big help for them. Stated it would be great to have ID to identify with authority, follow the law and be part of the community.

Father Denny Dempsey, thanked Council for their patience. Stated he has been in Northfield for 13.5 years and most of those in attendance have been here longer than that. Stated he has a great relationship with the Police Department. Adoption of the ordinance will be a big step forward in helping people feel they belong to the community. Noted the large number of people in attendance shows how important this is to them. Invited all to the celebration next week at St. Dominics.

City Administrator Martig introduced this item and answered questions posed by Council. City Attorney Hood provided information regarding the lease amendment.

Chuck Amunrud, 1400 Heritage Dr. Stated he moved here two years ago because of what the City offers. Stated he was not speaking against the project and knows there is a need. Questioned the isolation of the proposed location and noted that he moved to his current location for the ability to walk to services and amenities.

Dr. T. S. Turna, 1400 Heritage Dr.. Noted he has practiced in area for last 15 years. Noted company Riveredge Properties, LLC, owns Mosaic Apartments and 17 acres north of YMCA. Plans to build assisted living - 120 units total next to the Mosaic Apartments, 50 units independent living, 45 assisted living, 25 units memory care. Spoke regarding location and being within walking distance to everything. Stated he is willing to work with City to include some low income housing. Noted the project will be on him with appropriate help from the City. Stated his concern with the City turning over lease and losing the uniqueness of the City owned Hospital. Feels the City would be giving away a valuable asset and limiting future expansion. Stated the City has more than one option.

During the discussion of this item, Mayor Pownell asked for a motion to extend the meeting.

At 10:32 pm, Council Member DeLong called for a point of order noting that it was 10:32 pm and asked if the meeting should automatically adjourn.
