OPEN PUBLIC COMMENTS

Paul Hager, 110 Maple St, spoke regarding concerns about Municipal ID information database being public information that could cause potential harm if seen by government agencies such as ICE. Understands the need, but believes that a community organization should instead head the project in order to keep the personal information of those with a Municipal ID card private.

Don McGee, 710 Highland Ave, spoke about the street improvement project approved on December 5. States while there was much discussion about Washington and 7th, there was no discussion about the Division and 7th intersection. Noted a raised intersection has no curbs and therefore no barriers to differentiate between street and sidewalk and believes this is a serious safety issue. Encouraged Council to give the Division and 7th intersection the same consideration as they did the Washington and 7th intersection.

Gordon Moreno, 506 Winona St, spoke in favor of the Municipal ID. Shared a personal story about training Mexican-American boxers in Northfield for the last 20 years and his experience and interactions that he has had.

City Administrator Martig introduced this item and noted changes made since the first reading. The effective date of ordinance will be March 1, 2018 and City hopes to be taking applications and implementing process by March 31, 2018.

City Attorney Hood answered questions posed by Council regarding personal and private data retention. Noted the data being collected will be minimal and documents will not be kept. All data is subject to the Government Data Practices Act, regardless of whether it is handled by a private non-profit or a government entity, because it would still be funded by a government organization.

Linda Burdell, 714 Orchard Pl, spoke in support of Municipal I.D. Noted the positive aspects of the program and that the program is being created during a time of division.

Stated it gives Northfield residents a shared identity. Feels proud of her community and city.

Olivia Frey, 401 Highland Ave, spoke in support of the program to help homeless youth and adults in Northfield. Stated some homeless people are unable to get a copy of their birth certificate and are therefore unable to get a state-issued ID.

Mar Valdecantos, 6 Fareway Dr, wanted to acknowledge the students of Carleton who could not attend tonight as their term has ended, but stated they have been very helpful. Noted St. Olaf students are present tonight.

Taide Rodriguez Marcial stated she is thankful for the support from the community. Noted how helpful the Municipal ID will be to her and her family.

Angelique Dietz, 616 E 5th St, spoke about the strong symbolic value of the Municipal ID and what is says about our community and it's inclusiveness. Urged Council to vote in favor.

Pearl McAndrews and Julia Valero, 1500 St Olaf Ave, stated their support of the Municipal ID and spoke regarding the benefits it will provide college students who otherwise need to carry their passports with them around campus.

Scott Nesbit, 420 W 2nd St, stated he is excited about the Municipal IDs. Urged those with driver's licenses to also purchase and use a Municipal ID to help stand with and in support of those without driver's licenses.

Emery Rankin Utevsky, 1500 St. Olaf Ave, spoke about the additional benefits of the card including preferred name and gender option. Described the barriers to changing a name legally. Thanked Council.

Leota Goodney, 212 Ames St, spoke in support of Municipal ID for elderly and dementia patients. Stated it will be helpful for them to carry a card that does not include a lot of personal information.

Suzie Nakasian, 713 4th Street E, spoke on the importance of the card for all Northfield citizens and not just undocumented immigrants. Shared a personal story about her father immigrating to the U.S.

Kathy Schuurman, 509 Ivanhoe Ave, spoke about excitement to be able to use her preferred name, Kathy, rather than her legal name, Henrietta.

Marieno Spinos shared how difficult it can be as a refugee and what it is like to be separated from family and loved ones. Stated today we can share a story about how democracy works and how we can work together. Thanked Council for making history.

Jon Denison, spoke regarding his concern about data recording and how it could be shared with federal agencies. Stated there are no safeguards that will keep the information out of the hands of federal agencies.

City Administrator Martig introduced this item. Gave an overview and history of the proposed project. Martig noted Hospital sees the project as complimentary to their mission. First phase would need to be started by June 2018 and finished by the end of the year 2020.

Community Development Director Heineman summarized the comprehensive plan guidelines and discussed the zoning of the area. Introduced Chester Yanik, Chairman of Yanik Companies, Steve Underdahl, Northfield Hospital and Clinics President and CEO, Jerry Ehn, Northfield Hospital and Clinics COO, and Mark Elliot, St. Olaf. COO. All answered questions posed by Council.

Steve Underdahl explained that the hospital's current long term care is not sustainable. Stated hospital looked into starting their own project, but was not feasible without partnership. Answered questions posed by Council.

Don McGee, 710 Highland Ave, spoke in favor of the project. Says Council and it's predecessors have already laid the groundwork.

Jon Denison, noted he does not like comment cards because it is not required by the Charter. Spoke in favor of the project. Says it would create hundreds of new jobs and is a rare opportunity. Says it will increase wages locally and is a big deal.

Dr. Turna spoke regarding concern that Yanik describes helping those that cannot pay, but not putting any of that in writing. Asked if there is a written agreement for 15 beds to be assigned to charity. Discussed concerns regarding feasibility of the project.

Charlie Kyte, 450 Rosewood Ave, Chair of the Hospital Board, stated that there has been a Council representative at almost every Hospital Board meeting where the project was discussed. Noted the project will increase City's tax base.

Councilor Colby left the room at 8:41 p.m. and returned at 8:43 p.m..
