*Finance Director Angelstad introduced Nick Anhut, Ehlers Associates. Mr. Anhut presented results of the bond sale. Noted there were four bids received. Stated the update from Standard & Poors affirmed the City's AA rating. This rating attributes to the low cost of borrowing. The bids were favorable with a 2.70% true interest cost. Anhut recommended accepting the bids and awarding the 2018A Bonds to United Bankers Bank. Anhut answered questions posed by Council.*

**A motion to amend was made by Council Member Zweifel, seconded by Council Member Nakasian, to approve Resolution 2018-093 Adopting a Proposed 2018/Payable 2019 Tax Levy with a 7.45% preliminary levy.**

**Council Member Nakasian withdrew her second to the amendment. Mayor Pownell stated that there was no amendment on the table.**

**Council Member DeLong appealed the ruling of chair noting that he did not have time to second the motion. The appeal was sustained by the following vote:**

Noted the statutory urgency and that the Statute requires co location agreements. Stated the level of detail in this agreement is new. Provided copies of proposed changes to the agreement.*
