#### Recognition of Mike Ericson, Interim Community Development Director

City Administrator Martig and the City Council recognized and thanked Mike Ericson, Interim Community Development Director, for his service to the City of Northfield.

2. 18-600 Presentation by Bridgewater Township Related to Northfield Annexation Agreement Status and Exploration of Incorporation.

> City Administrator Martig introduced this item. Glen Castore, Bridgewater Township Supervisor, presented information regarding potential incorporation by Bridgewater Township. Castore noted the township is 36.2 square miles, has approximately 1800

people in 650 households. Castore noted the limitations the Township is experiencing from Rice County, such as being prohibited from development and housing clusters. Castore answered questions posed by Council. Castore invited the Council to upcoming meetings on this topic and noted he would provide the locations.

Mayor Pownell asked if information can be brought back on railroad quiet zones from the consultant related to the work they have done in Rosemount.

Ehn noted that the Hospital Board met on November 29, 2018 and recommended moving forward with the project. Ehn noted the total dollars available for the projects is \$13 million, reviewed the proposed schedule, and answered questions posed by Council. Ehn noted opportunities to provide input on designs to the board.
