Peter Swift, 206 Madison Str. S., spoke regarding the May 15 Northfield News article on a potential floating walkway on the Cannon River. Swift spoke about the cost and better uses for the money, liability, and that there are many places for people to cross the river.

12. <u>19-964</u> Public Hearing on TIF Request by Schrom Construction.

Mayor Pro Tem Ness declared the public hearing open at 6:13 pm and noted that the Council will take public input and continue the hearing to the July 23, 2019 City Council meeting. A new public hearing notice will be published. Economic Development Coordinator Carlson introduced and provided information on this item. Nick Anhut, Ehlers, provided information on Tax Increment Financing, the proposed project, terms, developer requirements, and process. Anhut answered questions posed by the Council. Economic Development Coordinator Carlson and City Planner Tempel answered questions posed by the Council.

Victor Summa, 812 St. Olaf Ave., spoke regarding Mr. Anhut and thanked him for the information. Noted he did not have a problem with TIF, but feels this is a project that shouldn't be located at the proposed location.

13. <u>19-965</u> Consider Motion to Amend Ordinance 1006.

City Planner Tempel introduced this item and explained that the version of Ordinance 1006 approved on first reading June 18 was incorrect.

Victor Summa, 812 St. Olaf Ave., suggested the communications between the HPC and building owners should be better.

A motion was made by Council Member Peterson White, seconded by Council Member Nakasian, to direct staff to present a revised Ordinance 1006 as attached on Signage in the Downtown Historic District for the July 23, 2019 City Council Meeting. The motion carried by the following vote:

14. Ord. 1005 Ordinance vacating drainage easement on Outlot A Southbridge 1st Addition.

Public Works Director/City Engineer Bennett introduced this item and answered questions posed by Council. City Attorney Hood provided information regarding this item

and answered questions posed by Council. Hood noted it was in the public interest to vacate the blanket easement and that the blanket easement is most likely not enforceable. Hood summarized the primary issues and stated he is unable to find a single legal document that would allow the City to claim that Outlot A is a park or should be a park.

Victor Summa, 812 St. Olaf Ave., spoke regarding Hood's phrase in the public's interest. Noted discussion didn't center on what is in the public's interest. Spoke regarding protecting the constituents interest. Noted concerns previously expressed regarding the dead end cul-de-sac related to traffic and emergency vehicles.

Vern Koester, 2351 Division Str. S., spoke regarding the question of gifting land and noted he did gift 6.05 acres, the land directly north of Southbridge townhomes. He noted that there was a typo in the letter referring to this as Outlot A and that he may have a document showing that scratched out. Spoke regarding drainage easements and noted he talked to an attorney who told him blanket easements are more common in rural areas. Noted easements need to be surveyed and defined. Stated a drainage easement is needed and this should have been a defined easement to begin with.

Lana Rich, 538 Ford Str. E., noted there are 10 residential homes in the area. Stated it feels like an enclave surrounded by multi-family and wonders if that is the direction the city wants to go. Noted she understands the need for housing and affordable housing.

A motion was made by Council Member Zweifel, seconded by Council Member Peterson White, to approve the second reading of Ordinance 1005 - Vacating Drainage Easement on Outlot A Southbridge 1st Addition. The motion carried by the following vote:
