Whillock reviewed the general concept of the Northfield Enterprise Center (NEC) and the services they offer.

Discussion was held on:

- -overcoming language barriers, increasing knowledge and trust throughout different ethnic groups
- -if this is the right contract size for this organization
- -having certain services of the NEC be paid for by the clients
- -potentially creating a \$500 grant for new businesses funded by private investors within the community
- -how to incorporate retired business owners who want to contribute to local businesses
- -connecting the NEC with City contracted Language Line services
- -connecting Strong & Starlike's work into next year as programming is developed
- -how the three year contract can be discussed at any time
- -cost of living increases for contracts like these

Carlson introduced the 5th Street Loft project. Baker and Carlson presented a PowerPoint on the proposal from Stencil and Rebound with the Tax Increment Financing (TIF) and Business Subsidy requests.

City Financial Advisor, Nick Anhut reviewed his financial analyzes of the project and described how the TIF program works and how the projects meets the TIF requirements. They have compared this project to other projects across the metro and greater Minnesota and found that the project will need assistance to provide additional capacity to meet some return thresholds in the future.

The Developer requested a \$250,000 loan from the EDA, land contribution from the EDA valued at \$212,000 and a Redevelopment TIF district pay-as-you-go for 25 years from the City Council. Anhut advised that EDA and City incentives would be tied to recourse provisions should the project not materialize as well as requesting the developer to defer part of their developer fee.

Ackerman noted her concerns and exited the meeting at 8:31am.

Peterson White requested further information from Loan Subcommittee members and wanted to understand what provisions would be in place should the project over perform.

Strobel noted favorable interest rates are available. However, investors are no longer receiving returns of 10% in today's economy. Strobel questioned the developer as to the timing of the project.

Leatham noted the benefit of getting more people to the downtown with this project and the positive signal to other developers for potential development.

Pownell requested staff to explain why the TIF needs to capture the Washington Street parking lot.
