Engineering Manager Simonson introduced this item and answered questions posed by Council. Public Works Director/City Engineer provided additional information on this item and answered questions posed by Council.

Ruth Neuger, President of St. Johns Church, suggested communicating notice of meetings in a way that makes it easy for people to be aware and to attend meetings. Spoke regarding the three major users in this area Longfellow School, St. Johns Church and the Northfield Arts Guild. Asked for an increase in traffic calming measures and suggested a bumpout at Poplar & Third Street. Noted many people are crossing the street mid block after Arts Guild performances in the dark.

Tim Peterson, Northfield Arts Guild, expressed appreciation for things being looked at in advance. Looking at relocating plays depending on timing of the project. Noted the Arts Guild did not request the plaza and just learned of it at the meeting. Stated they are not against it and are in support of traffic calming.

Jim Anway, 517 3rd Str. W., spoke regarding crossing Highway 3 and in support of the quiet zone idea. Spoke regarding speed and type of traffic on 3rd Str. Stated he looks at the improvements as a useful tool in slowing speeds down. Noted he had previously filed an online complaint about speed in the area. Spoke regarding accidents in this area.

Dave Neuger, Facilitator of Northfield Roundtable and member of St. John's Church. Spoke on behalf of the Northfield Roundtable, stated the plan is consistent with the framework plan. The design concept fits well from a community perspective. Stated the plaza at the Arts Guild makes good sense from a safety perspective. Feels improving safety and aesthetics is a good match. Spoke in favor of what is proposed.
