Chair Gasior read the public hearing opening statement and called the public hearing to order at 7:03 PM.

Tempel stated this is a request to increase the building area ratio (BAR) from 30% to 35% on 4 lots in the Hills of Spring Creek 8th Addition.

Chair Gasior invited the applicant to speak.

Steve Schmidt - 1600 Huron Ct. - stated the homes meet all the setback requirements, but given the unique shape of some of the lots (due to the curvature of the road and reduced size), they are losing square footage and that is what is creating the difficulty to compile with the building area ratio.

thought was to have smaller lots to encourage density, but the hardship now is building homes on the smaller lots. He noted the curve of the roads has created difficulty as well to meet setbacks.

Discussion was held on: -if 35% lot coverage would be adequate, -the couple hundred sq. ft. of home that would have to be reduced if Schmidt were to *build with the 30% BAR, -the original intent of the 30% building area ratio, -and how this is a chance to revisit the language.*
