Sparby noted the Economic Development Authority (EDA) has committed to support \$7000.00 for the next two years with the ability to raise \$3000.00 in matching funds.

#### Discussion was held on:

- -how the Riverwalk Market Fair (RWMF) started with funds from a Southern Minnesota Initiative Foundation grant and the EDA,
- -how the organization would like to continue to grow and they have had turnover in staff over the last couple years,
- -balancing recruitment, marketing and outreach,
- -adding more variety of vendors and incorporating the businesses downtown,
- -connecting with the colleges.
- -reaching out to underprivileged communities,
- -collaborating with the Link Center and the Supplemental Nutrition Assistance Program (SNAP),
- -having the Northfield Farmers Market join the RWMF, but the Farmer's Market vendors are hesitant to join because of the cost, the requirement to have a tent and they would have to stay the entire time the RWMF is operating,
- -how to remove those barriers for the Farmers Market vendors,
- -gathering input from local artists,
- -what changes could be implemented to become more inclusive,
- -creating a space for farmers or other vendors so they don't have to stay for the entire RWMF.
- -capatilizing on the other events,
- -how the RWMF is a member of the Chamber and tourism dollars have been utilized for advertising of the RWMF for the last 3 years, which includes outreach to Rochester, -and partnership with the Northfield Enterprise Center (NEC) for the vendors to receive business coaching or other help.

The group then discussed reporting expectations and decided on a fiscal August report,

an end-of-year report in November or December and a goals/vision/long-term report in May or June.
