City Planner Mikayla Schmidt introduced the item presenting background information on the Conditional Use Permit (CUP) request from SV CSG Northfield, LLC for a 1MW Solar Garden. Schmidt outlined the additional conditions for the CUP. Patrick Dalseth, SunVest Solar, addressed the Council explaining the project requesting the Council consider a 35 year contract versus 25 years as per staff recommendation. Public Works Director/City Engineer Dave Bennett, Schmidt and Dalseth answered questions from the Council.
