Summary Report:

City Administrator Martig is working with Craig Rapp on scheduling for the Strategic Planning process. There has been one modification to change the separate focus groups of the EDA and Planning Commission to a joint facilitated meeting of the City Council to create a shared vision for common priorities and key projects. The following is a summary of the current schedule awaiting final confirmation of Councilor availability:

April 11 - City Council, Planning Commission, EDA - strategic planning session
May 9 - Strategic Planning 1 and 2
May 10 - Strategic Planning #3
