Sec. 2-307. - Authority reserved to city council. The city council shall have the exclusive authority to: (1) Construct any additional hospitals or additions to the present hospitals, convalescent homes, nursing homes and related medical facilities including medical clinics.

(2) Construct any appurtenant structures.

- (3) Acquire any real property for any hospital or related use.
- (4) Buy or sell any of the above mentioned facilities or property.
- (5) Levy or impose taxes for the operation and maintenance of any part of the hospital system. (Code 1986, § 255:00(3); Ord. No. 779, 2-18-03)
