Consider Resolution to Join the Membership in the Coalition of Greater Minnesota Cities (CGMC).

Action Requested:

The Northfield City Council is asked to consider the attached <u>Resolution</u> to join the membership in the Coalition of Greater Minnesota Cities.

Summary Report:

The Northfield City Council received a presentation from the Coalition of Greater Minnesota Cities (CGMC) at their January 11, 2022 worksession detailing the membership benefits. Attachment 1 is the resolution to join the CGMC.

Attached to this report are a number of documents containing information related to joining the CGMC. Alternative Options:

City Council may decide not join the CGMC at this time and therefore not adopt the resolution. To become members requires approval of a resolution.

Financial Impacts:

New member cities or returning member cities of the CGMC that have not been members within the past five years are able to join the organization on a phasing-in dues schedule that allows you to join at 25% of your total calculated dues, phasing up to 100% in year four of membership.
